Park Updates

We are very excited to erect the privacy fence between our park and the newly constructed NPT connection. The process of getting the funds from the city has proven to be more time consuming than we originally anticipated. The city has been good to work with but their process is not built for speed. Two weeks ago an acceptable agreement was presented and signed with the city, we just await the transfer of funds. Once we have the funds, construction will begin.

We are also very excited to get started on a bridge and new community space on the other side of the creek! Because the bridge is in a flood plain, we had to seek permits from the Department of Natural Resources (DNR), Hamilton County, and the City of Fishers. We submitted plans to the DNR in May, they requested a computer hydraulic model which we have acquired and submitted back to them. Their approval process, as we have learned, is also not built for speed. The city has tentatively approved our plan dependent upon the DNR's approval. I believe we fully comply with everything they need from us and expect to have the permits. As soon as we do, construction will begin. If we do have any structural engineers in the neighborhood that might be willing to volunteer your knowledge, please email president@berkleygrove.com.

We are very excited for these projects, they have required more time than originally expected, but will be well worth the effort and time.

Berkley Grove 2023 Covenant Amendment —APPROVED

As you recall from previous newsletters, Fishers mayor Scott Fadness had recommended all HOA's in Fishers adopt rental restrictions as the Fishers housing market has been targeted by nationwide rental companies.

After consultation with our attorneys and residents at the Annual Meeting and Town Hall meetings, the Board drafted a recommended amendment and distributed it to all residents.

With the help of the newly formed Block Captains, before the midnight deadline on August 11, 2023, we received 185 favorable votes; 37 opposed, and 21 no response. Therefore, we obtained a little over the 75% homeowner approval needed to amend our Declaration of Covenants to add new rental restrictions. This rental restriction includes a 'cap' on the number of rentals as well as establishes a 3-year waiting period before new homeowners can approach the board to rent their home.

On September 8, 2023, the Amendment was filed with the Hamilton County Recorder. As of that date, our Berkley Grove community now has a cap on rentals so that no more than 5% of our homes can be rented to non-owner occupants at any given time. The recorded copy is posted on the Berkley Grove website at https://berkleygrove.com/forms.

A formal letter has been mailed to all homeowners including owners of current non-owner occupied properties.

The Board appreciated hearing from the majority of the residents. Whether you were for or against the amendment passing, the Board felt it was important that we gave all 243 homeowners an opportunity to be heard.

Earlier this year we revived the block captain program Berkley Grove had in decades past.



Architectural Review Forms ...

Submit an Architectural Review Form as you begin planning **any** project that affects the outside of your home or yard (excluding routine landscaping, non-permanent playground equipment, or if you are repainting your home or trim the exact same color). Per the Berkley Grove Covenants, Section 3(C), and Section 6 (A)(i), this form needs to be reviewed and approved by the Architectural Review Committee **before** your project begins.

Berkley Grove Covenants Common Violations

If you are in violation, you will receive notice

- Planning an outdoor project; submit an Architectural Review Form BEFORE project begins
- Maintain continuous dust-to-dawn lighting controlled by a photocell on the side of your garage or yard light
- Trash Bins should not be visible from the street except on trash pick-up day
- Cut down and remove all dead trees/ shrubbery
- Keep the exterior of your residence in such a state of repair or maintenance as to avoid it from becoming unsightly including repair to rotting wood and flaking paint
- No trucks one (I) ton or larger in size, campers, trailers, boats, or similar vehicles shall be parked on the street. Be advised of the City Ordinance making this a violation if parked visible of the street (in driveways).

Be courteous of your neighbors and keep the sidewalk in front of your home free from snow and ice in the winter, tree limbs and lawn clippings in the warmer months.
